# Introduction

The present publication is dedicated to the projects selected in 2012 under the call for proposals for the Implementation of the European Agenda for Adult Learning.

The Compendia are part of the Executive Agency's contribution to a better dissemination of information about ongoing projects and to an improved networking among project coordinators.

In the Compendium you will find a short description of each project, as well as the contact details of the beneficiary and coordinating organisations. Please note that the Compendium reflects the state of the projects at the selection stage (in July 2012), which means that data such as duration or contact details may change during the lifetime of the project.

The Council Resolution on a European Agenda for Adult Learning, adopted by the Education Council on 28 November 2011, concentrates on increasing participation among the low qualified and disadvantaged adults, with a focus on developing their basic skills, for example through guidance, validation and access to second chance initiatives.

The Agenda encourages the LLP participating countries to take concrete steps to enhance, intensify and coordinate policies to provide adult learning, in particular offering lower qualified adults a "second chance" to go "one step up" in their qualification level.

To facilitate liaison and effective implementation of the Agenda at national level and to cooperate with the Commission in its implementation at European level, the Council Resolution provides for the designation of national coordinators, having the necessary level of responsibility and technical competences in the field of adult learning, located in national administrations or other agencies operating under the responsibility of these.

The EU funding in 2012 is intended to co-finance the participation costs of those LLP countries that want to participate in the activity. The purpose of the grant is to support national administrations, through the coordinators, in implementing the Agenda with a wide range of stakeholders and in a wide range of settings. The objectives are to:

- Inform and raise awareness of the Agenda and the importance of adult learning more generally;
- Organise exchange and debate with all relevant stakeholders at national, regional and local level to mobilise cooperation that could help reach a maximum number of adult learners;
- Act on the recommendations of the High Level Group on Literacy and use the "Basic skills: policy and practice guidelines", which resulted from the Action Plan on Adult Learning;
- Support transnational cooperation in the development and implementation or consolidation of national and regional initiatives offering adults a second chance to acquire basic skills.

**Title:** NL-IMPLEMENTATION OF THE EU AGENDA FOR ADULT LEARNING

**DESCRIPTION:** As in many European countries, also the Netherlands is facing a considerable amount of people lacking the basic skills for entering and staying in the labour market and, for a part of them, even to fully participate in the society. On the other hand, we are expecting shortness of labour in particular in the healthcare sector, technical sector and in the green sector. A result of the current crisis is that people need to work longer. It is known that among the group of elderly who have to work longer now the requested skills are lacking. The project described below will support people to participate fully in society and to decrease the expected shortness of labour by upgrading their skills and competences.

The following target groups are envisaged to participate in the project:

- The different stakeholders at national and regional level: social partners, government (ministries of education culture and sciences, care welfare and sport and social affairs), local municipalities, institutes for work and income, the reading and writing foundation;
- Participants: people who want to re-integrate the labour market and lacking the required basic skills, in particular, in the sector of care and welfare;
- Providers working with people who are lacking basic skills.

The expected impact will be the following:

- By using the European instruments in an integrated way low skilled and/or low qualified people will be better supported and be able to obtain in a more efficient way a qualification which will help to enter the labour market
- Better cooperation between the different stakeholders at regional and national level.
- Established cooperation with, in particular the neighbouring countries.
- Monitoring and presentation of the results and recommendations for the follow up.

The following methodology will be used:

- Validation of people's skills already obtained, in particular at the level of basic skills. The people will be identified by the institutes for work and income and employers. Based on results of the validation process, tailor made learning will be improved, further developed and offered. As there is an immediate lack of people in the sector of health care this project will focus on this sector.
- Organising round tables with the different stakeholders at regional and national level to discuss the possibilities to decrease the number of people lacking basic skills and for that reason having difficulties to enter and stay in the labour market among making use of European instruments.
- PLA with a limited number of participants on how European instruments are (or can be) used to help people to go "one step up".
- Monitoring results and communication of results, challenges ahead and problems still to be solved to a wider audience.

**DESCRIPTION:** The primary goal of the project is to improve the access to lifelong learning and to motivate disadvantaged and low skilled people to participate in education. We intend to expand the existing courses and establish missing courses in basic skills (literacy, numeracy, ICT, foreign language skills, active citizenship). Only if we are successful to create an attractive overall framework the group of low educated and low skilled people will be able to be brought forward to mid-level qualification. In addition with this project we will demonstrate the great importance of adult education in the educational landscape. A stronger, innovative and systematic promotion of adult-oriented form of education is the key point for the realisation of lifelong learning.

As personal resources are limited in our small country and especially in the field of Adult Education Liechtenstein, four working groups are formed which are involved throughout the whole project duration (part-time work by agreement): National Authorities; Economic and Industrial Chamber; Trade Union; providers, teachers and trainers. It is extremely important that all stakeholders are involved and that the project is supported by their wide knowledge and active support.

We will also carry out awareness-raising courses (sensitisation courses for intermediaries). The courses are for people who are in touch with the target group (national departments, communities, associations, medical services etc.). A professional counselling centre will facilitate the entry of the target group in education and supervise the further educational pathway.

Due to the high individualisation of the courses, the actions to be taken will have a relatively large variety in the content design. The individual modules can be flexibly designed taking into account the specific needs of the target groups. Education for vulnerable social groups must be very inexpensive and affordable for everyone. Therefore, we will develop a concept for the delivery of education vouchers. The expenses of the vouchers will be charged to the regular budget of Adult Education Liechtenstein. They will be distributed generously, also after the project ends. The targeted marketing and PR campaign is an important component of the project. The working groups of providers and teachers/trainers commit themselves to participate in the monitoring and evaluation of the measures.

The target groups are people with German mother tongue which have deficits in basic skills (with or without school leaving qualification) and persons with an immigrant background and lack of basic skills.

The impact envisaged is to realise in the medium to long-term a balanced and comprehensive basic skills education program for adults on a national level.

**DESCRIPTION:** The number of adults taking part in adult education and training is quite high in Luxembourg but some courses (individual educational offers) are inadequate. In addition, the opportunities of professional development for adult trainers are not in line with the needs of the education and training centres and some target groups are underrepresented (unqualified and disadvantaged people). This is why among the priorities for 2012-2014 this project tackles the following specific priority domains: 1) increase the educational demand, notably for disadvantaged people and for adults in general; 2) promote flexible learning pathways; 3) improve adults' competencies in reading, writing and numeracy and improve the quality of education and training.

The actions which will allow to meet the above-mentioned challenges are:

- the implementation of new flexible and personalized learning mechanisms, allowing adults to complete an individual training pathway in view of their access to a qualifying and guided training, to be prepared for official competitions, and to acquire basic competencies or skills for professional promotion;
- the development of a national framework of basic competencies for adults and the promotion of basic training offers among institutions and social services as well as among the potential learners;
- the implementation of actions increasing the visibility and quality of adult education and training. As regards visibility, promotional activities will be undertaken in different contexts and in collaboration with the coordinators from other European countries. With reference to quality, the focus will be on the creation of a coherent and flexible mechanism for the professional development of adult trainers, thus answering the educational organisations' needs from the public and private sector.

The impact foreseen is the increase in the participation and quality in adult education as well as the diversification of the educational offer.

**DESCRIPTION:** The main motivation for planning activities and creating the project is current low participation in adult learning in Croatia (Eurostat). Republic of Croatia is lagging behind compared to developed EU countries regarding participation of adults in different forms of learning. Much needs to be done to raise public awareness about the importance of lifelong learning and to build synergy among all stakeholders with the aim to create effective adult learning system in Croatia.  
The project in Croatia will motivate stakeholders to take an active role in developing adult education system and policy and will also contribute to develop adult learning in Croatia in line with the European Agenda for Adult Learning, especially to:

- foster greater awareness among adults that learning is a lifelong endeavour which they should pursue at regular intervals during their lives, and particularly during periods of unemployment or career transition;
- promote the role of social partners and civil society in articulating training needs and developing learning opportunities for adults, as well as optimise the involvement of central, regional and local authorities;
- involve social partners and raise their awareness of the benefits, also to them, of learning in the workplace, including basic skills provision;
- foster greater awareness among employers that adult learning contributes to promoting productivity, competitiveness, creativity, innovation and entrepreneurship, and is an important factor in enhancing the employability and labour market mobility of their employees.

**DESCRIPTION:** Adequate provision of Basic Skills Training (BST) for adults is one of the main conditions for the successful implementation of national policies for lifelong learning. Norway has put in place a number of measures to ensure that low qualified adults are able to take "one step up" in their qualifications, but the provision of BST is still fragmented into different sectors and areas of responsibility and its quality, although assumed to be relatively good, is not ensured by any national quality system. Some of the sectors involved have put in place a system for accreditation of providers and measures to ensure the initial training and continued professional development of BS teachers, but we lack a consistent quality framework.

Creating a complete Quality Framework for this sector of AL is not possible within the scope of this project, but, in line with the intentions of this restricted call, the Norwegian National Coordinator aims at:

- Establishing a consensus among all sectors and stakeholders involved about the need to focus on quality of provision for BST;
- Identifying the most urgent issues and the possibilities for synergy between initiatives in the different sectors;
- Coordinating the efforts of all stakeholders with the aim of creating the first draft of a road map called "Towards a Quality Framework for Basic Skills Training Provision in all sectors of Norwegian Adult learning".

The activities of the project group will include:

- Identify representatives from all involved sectors and stakeholders and invite them to contribute to a National Task Force group;
- Identify and seek to involve experts from European countries that have already created partial or total Quality Frameworks in this field;
- Both contribute to and profit from the parallel work done within the Commission's Thematic Working Group for Quality in Adult Learning, as well as keep an open line towards all other NC to profit from possible cooperation;
- Organise at least two international gatherings during the project's life to create an arena for dissemination of results, benchmarking and discussions;
- Draft a Road Map identifying the steps needed to develop a National Quality Framework for Adults Basic Skills.

**DESCRIPTION:** Although Latvian government has actively stimulated adult learning by implementation of different programmes and instruments, the participation rate of adults of age 25-64 in lifelong learning in Latvia has declined from 7.1% in 2008 to 5.0% in 2010. In order to reach the ET2020 objective of 15% of adult participate in learning, there is a strong need for more coherent lifelong learning policy communication between partners at national and regional (local) level. In addition, more information for inhabitants should be provided about opportunities to take part in a learning process and available funds & instruments, especially for those with low education level that are the most difficult to reach. The project will simultaneously raise the awareness of the European Agenda for Adult Learning priorities in a wide range of settings – national ministries, NGO, social partners, local governments and residents – through the national and regional seminars.

The project objectives are:

- To strengthen cooperation with and between local governments in implementing the Agenda of Adult Learning and the national lifelong learning strategy,
- To create fora for policy makers and stakeholders to regularly exchange views on policy challenges and opportunities,
- To disseminate to residents information about existing instruments through the National information point (hosted by the Ministry of Education and Science).

The target groups of the project are:

1) National ministries involved in the implementation of the adult learning policy, 2) local governments that are by the Education Law entitled to ensure implementation of the national adult learning policy, 3) NGOs and social partners that are working in the field of adult learning. The mentioned target groups will be reached through the national fora where policy issues on adult learning will be discussed as well as through five regional seminars and national conference where good practice examples will be presented and taken into consideration.

2) Adults, especially low skilled and low qualified that have limited access to information about opportunities to participate in adult learning will be able to visit the newly established section of adult learning in the information centre of the Ministry of Education and Science.

**DESCRIPTION:** In Germany the coordination point will be based at the National Agency "Education for Europe" at the Federal Institute for Vocational Education and Training (NA / BIBB).

Through the creation of a coordination point and the implementation of all actions foreseen, the goals of the Agenda for Adult Learning will become better known to the public.

In order to reach these goals, a range of events have been foreseen including the organisation of national and international conferences, expert meetings and regional meetings with the participation of important multipliers and stakeholders. With the support of media, electronic tools (website, newsletter), and the production of own publications, information about the Agenda will reach a wider audience. A detailed calendar of events containing information about all planned national and international conferences and their outcomes as well as about all mechanisms in the field of political education related to the Agenda, will be published on the website. A national support group composed of representatives of Federal Ministry of Education and Research (BMBF) and Federal States (KMK) will be established.

The coordination point will play the role of an ambassador for the concept of Adult learning. For the period 2012 – 2014, literacy and basic education are set as a priority. The planned conference will focus also on the topic of basic education.

The activities of the coordination point are open to all the actors from the field of adult learning policy in Germany. Adult learners should be addressed directly concerning the goals of the Agenda related to labour market and personal development, an aspect that will increase their participation in adult learning.

**DESCRIPTION:** Ireland proposes to implement the European Agenda for Adult Learning through three interlinked projects which together will serve to increase awareness of adult learning as part of lifelong learning at both national and local levels.

Alongside an increase in unemployment, people need to upskill throughout their lives to access future employment opportunities and to participate more fully in society. In Ireland, we want to increase awareness of both the need for and availability of adult education. Under the Agenda, we have devised three projects which together will help achieve this aim. They are:

- An online calendar of events;
- A referral service for people wanting to undertake adult education;
- A scheme to appoint Learner Ambassadors. The aim of the project is to promote adult learning at both a national and local level.

We propose to develop these projects in conjunction with AONTAS – the National Adult Learning Organisation, NALA – the National Adult Literacy Agency and the Irish Vocational Education Association (IVEA, representing Vocational Education Committees) well as other national, regional and local networks and stakeholders. We will build on work already done in this area – for example, we have toolkits and manuals for Learner Ambassadors from a project funded under Grundtvig – but also create these new initiatives on a sustainable basis.

The online calendar (which will be accompanied by a launch event, a marketing campaign and advertising through social media) will provide information on local events in local communities and give those communities an opportunity to publicise their events. The referral service will give learners another route through which they can find the right learning opportunity for them. The Learner Ambassadors and its sister programme, the “Encourage a Learner” programme, will publicise both of these projects while also giving people an opportunity to take inspiration and take that first step into learning.

These projects are mutually reinforcing and sustaining. They will be co-ordinated in their development to ensure maximum efficiency and effectiveness.

While these initiatives are targeted at all learners, those with less than upper second level education and the unemployed, in particular the long-term unemployed are a priority group. We hope that we can increase participation amongst the priority groups in adult education and to help build the image of adult education as a separate and distinct sector. This strategic objective fits well with domestic developments in the further education and training sector, namely, the establishment of a new further education and training authority – SOLAS.

**DESCRIPTION:** According to 2010 statistics, 28,6% of the Spanish population between the age of 18 and 24 years old had not completed secondary education and therefore had not obtained the Lower Compulsory Secondary Education Certificate. They had not participated in any other kind of education or training.

The national and regional educational administrations, aware of the problem, have developed flexible arrangements adapted to different training needs to allow these people to obtain this certificate and others. However, many possible beneficiaries don't know about the different pathways they can follow.

The aim of the project is to address the national and regional challenge of low education attainment levels in order to increase the quality of the workforce, foster social and human development and empower adults to advance in life. A means to achieve this goal is to increase the number of people who obtain the Lower Compulsory Secondary Education Certificate.

Two main problems have been detected that are an obstacle to successfully achieve that goal: lack of information about the opportunities available and lack of a good selection of materials to help learners to get prepared for the test that leads to the certificate.

In order to tackle these obstacles, during the two -years project we aim at creating an intuitive easily accessible Website which would contain comprehensive information about the different pathways that lead to certificates, and a resources bank of training materials to help potential learners to gain or boost the necessary skills and competences to obtain the certificate. The resultant materials would be uploaded in the Website.

The target group would be the Spanish nationals and residents who have not obtained the above mentioned certificate. In other words, early school leavers, young people not in education, employment or training (NEETs) and low-qualified adults.

We expect this project to help increase the number of learners who obtain a formal certificate and, on the long term, to keep these people in education and make easier for them to find or hold a job.

**TITLE: EE - IMPLEMENTATION OF THE EU AGENDA FOR ADULT LEARNING**

**DESCRIPTION:** The reason for this project is to enable and support the achievement of several goals set for adult learning.

First, while the EU target for adult-learning participation by 2020 is 15%, Estonian target is significantly higher - 20% (National Reform Programme "ESTONIA 2020").

Second goal also comes from National Reform Programme and aims to boost economy's competitiveness by reducing the number of adults at the labour market with general education (general secondary education, basic education or a lower level of education) but without specialised professional or vocational education. In 2010 this rate was 32% in 2010, for 2020 the target is 30%.

Third goal is set by the Development Plan of Estonian Adult Education and aims at making the management of the sector more effective and inclusive of parties. Government's Office audit in 2010 concluded that more cooperation is needed to govern the adult learning sector effectively.

The project provides awareness raising activities about adult learning in general and about the European Agenda for Adult Learning. By bringing together stakeholders and providing a discussion forum, the project improves the coordination and management of the sector of adult-learning. The project proposes solutions to the existing governance problems by means of setting up a national system of coordinated interaction among all stakeholders and the development of specific mechanisms and instruments for monitoring and assessment of the progress in the adult learning sector. Proposals for amendments and supplements to the legal basis, regulating the adult learning sector both horizontally and vertically will be prepared.

An intensive awareness-raising campaign will be launched for communicating the advantages of the targeted policies, as well as the envisaged substantial social impact of the process. The development will be focused on low-qualified workers, persons with literacy problems, elderly people and other representatives of disadvantaged groups. The portfolio for adult learning, established under the project, will be innovative in its proposed activities for Bulgaria. The electronic portal for processing and dissemination of data and analytical information on adult learning will be constructed on the official web site of the Ministry of Education, Youth and Science.

For identification of the situation in the adult learning sector six focus groups of different stakeholders groups will be formed. **DESCRIPTION:** The objectives of the project are:

- To support the development of adult education organisations in terms of reaching a larger proportion of low qualified adults, by providing a targeted group of municipalities with a forum for exchange of good practices and discussion.
- To support the development of how the participating municipalities can organise adult education and improve existing methods in order to best meet the needs of each student in heterogeneous groups.

The participating municipalities will be encouraged to exchange experiences on how to improve methods that aim at identifying and reaching low qualified adults, and motivate potential learners to participate in adult education. They will gain a thorough knowledge of the European Agenda and the European tools, and a clear idea of how to further the use of these recommendations and tools. They will establish a network that can foster on going development and continue after the project has expired. Municipalities will also have the opportunity to discuss and develop their working methods on how they can organise adult education, so as to best meet individual needs in heterogeneous groups.

The target groups are those responsible for adult education at local level, e.g. principal organisers, head teachers, guidance counsellors and/or development leaders, with special responsibility for municipal basic adult education, adult education at basic level for individuals with learning disabilities, and Swedish for Immigrants.

**TITLE: TR - IMPLEMENTATION OF THE EU AGENDA FOR ADULT LEARNING**

**DESCRIPTION:** Taking into consideration the demographic figures and labour force statistics of Turkey, opportunities and important risks are seen simultaneously. Turkey has one of the biggest populations in Europe which can be an opportunity for social development. However, Turkey has also the risk of missing this opportunity unless necessary progress on education and training, including adult education / lifelong learning has been achieved. This main aim of this project is to improve LLL culture and increasing awareness of adult education through seminars, symposium, trainings, brochures etc. during the project lifespan which is 24 months.

The following activities are planned:

- The project will start by analysing the current situation LLL participation rates and training needs analysis. According to the result of this analysis a report will be prepared and published and also will be announced in a National symposium to all relevant parties including decision makers. This will support decision makers to make new strategies and policies on adult education and improving LLL culture in Turkey.

- Non-formal training institution managers who have been newly appointed from 81 provinces will be reached through Seminars on adult education as they do not have specific experience in adult education. By this activity, it is aimed to increase their awareness and commitment to spreading lifelong learning culture in their provinces. They are playing an important role being the first cycle in adult education.

- Two spot films on adult education will be prepared and broadcasted on national TV Channels which will be drawing many people's attention on the importance of adult education and how their life could improve through education.

- 8100 unemployed adult particularly women from 81 provinces will be reached through Seminars on adult education. These people do not have enough information about the learning opportunities in their provinces and the institutions providing adult education. 25% of these participants are planned to be representatives of social partners, which work in the field of education particularly in adult education. Through this, the awareness of social partner representatives will be increased and social partners will play an important role in dissemination of the seminars on adult education.

**DESCRIPTION:** There is a growing concern about those who do not attend education after basic education (early leavers). In Finland, the fact that several thousand young people do not continue studies immediately after basic education, or drop out of the studies, has led to the situation that there are about 110 000 young adults (aged 20-29) without any qualification after basic education. In order to decrease these numbers, the government has decided to increase intake especially for this group in adult VET.

Support would be in need for finding, motivating and training these low qualified adults. This group is very challenging both to reach and as students. There may be problems in motivation as well as in basic skills needed for studies. There is a need to generally raise awareness of the existence of this group, raise awareness among this group about the possibilities of adult education and give them special support, to support education providers and to involve organisations and social partners.

Main target groups are the low qualified (only basic education) adults, especially 20-29 year old and stakeholders: education providers, social partners, employers.

The overall goal is to raise awareness among the low qualified adults about the possibilities of adult education (especially vocational), to increase their participation and to develop their skills. In order to reach this, the project aims at:

- motivating and supporting adults without qualification to participate in training and improving their skills;
- supporting vocational education providers in reaching the target group, in guiding and recruiting them and in training them;
- increasing awareness of possibilities to validate one's prior learning and to develop further the systems of identification and validation especially for low qualified adults with possible special needs;
- enhancing dialogue between policy makers, organisations and social partners to create a common understanding about the educational needs of low qualified adults, the ways to improve their education and training, and the role of stakeholders;
- supporting social partner and stakeholders to carry out guidance and counselling programmes;
- raising awareness among employers about possibilities to train employees and recruit new ones eg. through apprenticeship training.

The project activities include methods of awareness raising, disseminating and developing practices, of involving stakeholders, studying and following progress towards aims, and from learning from other countries.

**TITLE: LT - IMPLEMENTATION OF THE EU AGENDA ADULT LEARNING**

**DESCRIPTION:** During the recent years, active efforts have been undertaken to promote adult education in Lithuania. As a result, the country has witnessed quite a few progressive trends and positive changes. However Lithuania has not yet achieved the goals in adult education, which in turn impedes the development of knowledge economy and bettering the quality of life. In the current stage, in particular considering the adoption of the European Agenda, new political initiatives should be developed and further guidelines of developing lifelong learning drafted. Challenges, such as the recognition of competencies acquired in an informal way, implementation of more flexible funding models, promotion of cooperation between various levels of educational institutions and employers, inclusion of excluded groups into adult education and other relevant problems should be further discussed. Social partners and experts should be involved in drafting the national guidelines on LLL policy for the immediate future, so that they match the European trends and are in line with the other strategies of national education and social policies, e.g. Strategy Lithuania 2030.

The project activities are to:

- Analyse the experience gained during the implementation of 2008 – 2012 LLL Strategy and develop the national LLL Guidelines up to 2020, reviewing the national legal acts relevant for their implementation;
- Promote interinstitutional dialogue by holding a series of seminars and conferences with social partners on various challenges of adult education aiming to promote interinstitutional synergy, openness and dialogue;
- Organise information campaign for poorly motivated adults, advocate the opportunities for adult education and lifelong learning;
- Take part in transnational activities during the implementation of the Agenda and analyse the experience of other EU member states gained in organising adult education and lifelong learning.

The project, implemented during Lithuanian's EU presidency, is believed to foster various LLL initiatives. The direct participants of the project, such as education policy makers, administrators and representatives of social partners, will acquire new experience and develop relevant competences and international cooperation, whereas access to new learning opportunities will increase adults' motivation to learn.

**TITLE:** SI - IMPLEMENTATION OF THE EU AGENDA FOR ADULT LEARNING

**DESCRIPTION:** The project has been designed with the attempt to promote the implementation of the European Agenda for Adult Learning 2012-2014 but also to support national endeavours in adult learning – at political, professional and practical level. Special emphasis will be given to the two priority areas, i.e. awareness raising and attracting low educated/skilled and deprived target groups into adult learning (AL).

The output of the first set of activities will be 14 awareness raising events (7 per year in 2013 and 2014, in May) covering all Slovenian regions. The events will be connected to the major promotional event in the country, namely the Lifelong Learning Week (LLW), and to other AL networks (e.g. Lifelong Learning Centres). Through this project and in cooperation with regional coordinators, we will organise two series of 7 events, named Learning parade – days of learning communities. Each event will consist of a festival in a public place where (potential) learners and AL providers from all walks of life will demonstrate adult learning possibilities and achievements. In addition, there will be a formal event at each venue, bringing together various stakeholders – beside the before mentioned, local and national policy makers, various professionals and other interested parties will take part.

Related to the Learning parade will be the work towards a definition of 'a learning community' (at various levels) being a result of discussions of different stakeholders as well as analyses of literature and examples of learning communities in Slovenia and abroad.

The output of the second set of activities will be four video DVDs presenting activities and results of the implementation of an educational programme for the unemployed, the implementation of non-formal learning (rural literacy programme, study circle), AL information & guidance and validation of non-formal learning, as well as promotion of AL via stories of outstanding learners.

Both activities will be supported by ICT-based products – the Parade's website/calendar, blog for participants, connection to Facebook and other social media, and an e-bulletin documenting the happenings through the eyes of participants of the Learning parade. Finally, an e-corner for adult learning will be set up to promote ICT-based learning.

The target groups are mentioned in detail with regard to each activity; in brief, the project is envisaged to involve them all, i.e. representatives of AL policy, profession and practice, learners, media, the widest audience, however, with special focus on people with low educational achievements and skills, therefore classical outreach activities (e.g. personal contacts, local TV via videos, circular letters, etc.) as well as ICT-based ones will be used. The envisaged impact will be greater awareness on the importance, opportunities and omnipresence of adult learning as well as greater awareness on policy measures at all levels.

**TITLE: IS - IMPLEMENTATION OF THE EU AGENDA FOR ADULT LEARNING**

**DESCRIPTION:** A new act on Adult Education was adopted by the Icelandic Parliament in 2010 (Act Nr. 27/2010). With its adoption the Icelandic authorities confirmed their lifelong learning strategy, underlining the importance of providing second chance opportunities to education for the vast number of people in the labour market without formal education at upper secondary level. This act addresses the learning needs of this target group, defining the target group, specifying the organization of adult learning in Iceland, certification of curricula in adult learning, recognition of providers, financing and recognition of non-formal and informal learning, as well as quality assurance within adult education.

The new act brings on new tasks for implementation of adult education provision in Iceland and its connection to the European Agenda for Adult Learning. It calls for close cooperation with providers in this country, 10 lifelong learning centres, as well as other possible providers of education opportunities for adults in the capital area, including those who provide learning opportunities for migrants.

The new act on adult learning needs to be seen in context with other measures that have already been decided on by the Government, such as the 2020 Policy Statement (<http://eng.forsaetisraduneyti.is/iceland2020/>) which, amongst other benchmarks, envisages the lowering of the percentage of those without formal qualifications at upper secondary level from 30% to 10% by the year 2020. There is also the project Education for Employment (Nám er vinnandi vegur) which includes financing of particular measures aimed at strengthening VET and adult learning with funds of 1.850.000 euros for 2012 and the same amount for 2013. The project foresees closer ties to colleagues in other European countries and sharing of information on adult learning.

Seminars will be organized in major areas in Iceland in cooperation with providers where issues and challenges will be raised, measures taken will be introduced, how they are connected to the national strategy on lifelong learning and to the European Agenda for Adult Learning. Responsibility for organizing seminars will be given to individual lifelong learning centres to secure their full involvement in the project.

Target groups are Lifelong learning centres in the whole country, formal education institutions, regional authorities, guidance counsellors and the adult population at large.

**DESCRIPTION:** Adult education and continuing training plays an essential role in Denmark. It is crucial that all adults have the possibility of participating in both formal and non-formal learning activities with the purpose of promoting lifelong learning. It is the policy of the government to strengthen adult education and continuing training in order to promote employment, new jobs and active participation in society. **TITLE:** FR- Implementation of EU Agenda for Adult Learning

**DESCRIPTION:** The French actors involved in the education and continuing training of adults share the objective of the European Agenda for Adult Learning to increase the participation of less qualified adults in continuing training. Despite the existence of many schemes for the detection and support allowing many persons to access training and therefore increasing their basic competences, the identification and guidance of the persons who need it the most is still difficult, especially because of the wide range of actors and financing schemes. The objective of this project is first to implement a large scale consultation process between the main public and private actors in order to improve the access of less qualified persons to mechanisms which will allow them to acquire basic competences.

The project will focus in particular on:

- Young adults leaving the school system without qualifications therefore finding themselves without a job and without education;
- The rehabilitation of adults facing the greatest difficulties in finding a job and who are in need of support strategies and innovative financing schemes combined with the mobilisation of public, private; formal and non-formal actors for their inclusion.

In a second stage, this consultation work will be supported by meetings and observation of systems in other European countries as well as the dissemination of the most relevant experiences from France and other European countries through the publication of best practices. A mid-term conference will give the opportunity to share the observations and outcomes of the experimentations.

In a third stage, the operational committees will conduct practical experimentations with the goal to propose concrete recommendations. A review of these experimentations will be pooled during the closing seminar.

To assure the appropriation by the stakeholders, the activities of the coordinator will be implemented in consultation with the steering committee with representatives of different French actors involved in the field. The outcome of the experimentations and progress will be published on the website of the national coordinator.

The project will advance in three steps: a period of observation and consultation with the working groups, a period of implementation with the conference and finally a period of field experimentation with the operational committees.

**TITLE:** GR - Implementation of the EU Agenda for Adult Learning

**DESCRIPTION:** Greece has one of the lowest rates of adult participation in LLL in the E.U. (3,0% in 2010, Eurostat, LFS). Adult learning policies are top-down and supply-driven. For these reasons, the New legislation 3876/2010 on LLL provision aims at decentralising the provision, networking the key providers, encouraging partnerships and the gradual devolution of VET policies to the regions and of general adult learning to the municipalities. These processes are still at an early stage of development and will be facilitated by this project.

A bottom-up approach will be initiated by creating a network of key promoters of the Renewed Agenda such as NGOs, trade unions and municipalities, with a focus on developing the adult basic skills in contemporary economy and society. In addition, concrete steps will be taken to enhance, intensify, coordinate and modernise the current "second chance" provision by increasing the volume of cooperation with European organisations to draw on successful practices.

The objectives are:

- To create a special network of key stakeholders at grassroots level to promote the need for and seek provision of modern adult basic skills in collaboration with local authorities and other social agents;
- To improve the quality of the current provision of adult learning in order to become more attractive, less time-consuming and cost effective;
- To benefit from the studies, tools and processes of the OMC, already developed at E.U level;
- To transfer and adapt concrete effective practices, where appropriate;
- To produce policy recommendations for the provision of second-chance opportunities and the acquisition of basic skills.

The project will reach the following target groups:

- Adults who have left education without basic qualifications;
- Young people not in education, employment or training (NEETs);
- Older workers who need extra qualifications and/or up-skilling to stay in the labour market;
- People in retirement who need to stay active and participate fully in contemporary complex society.

Activities will include:

- The mapping of all relevant key actors and stakeholders in a national basic skills network;
- The organisation of 11 regional seminars and 2 conferences;
- Study visits in other European countries;
- The elaboration of common policy recommendations by the stakeholders and a Roadmap for action.
